Modern Slavery Act Statement

Slavery and Human Trafficking Transparency Statement for Financial Years 2019 / 2020

(1st January 2019 to 31st December 2020)

This Statement is made pursuant to Section 54 (Part 6) of the Modern Slavery Act 2015 ('Act') and sets out the steps that Abaco UK Holdco Limited, including its subsidiaries and branch offices ('Abaco') has taken during the previous financial year to ensure that slavery and human trafficking is not operating within either its own business or its supply chains.

This Statement has been approved by the Board of Directors and signed on their behalf by Alex Baldock, Managing Director.

Company Overview

Abaco is a UK based designer and supplier of ruggedized computing and networking products, systems and services that is wholly owned by Abaco Systems, Inc., a US based corporation. Abaco has several subsidiaries and branch offices that are controlled by Abaco and comply with Abaco principles, policies and procedures.

Abaco has a centralised sourcing function based in Towcester, UK and works in alliance with an independent network of suppliers and distributors throughout the world. Whilst these distributors are neither owned nor controlled by Abaco, it nevertheless remains an important requirement that they operate to the same anti-slavery and anti-human trafficking principles applied by Abaco in relation to its own business and to that of its supply chain.

Abaco's Philosophies and Principles

Abaco strives to ensure that it does not contribute towards adverse human rights impacts through its supply chains. Abaco's Code of Conduct and Business Ethics Policy and the Abaco Systems Integrity Guide for Suppliers and Contractors provide a set of rules based on both national and international standards to ensure Abaco's employees, suppliers, agents and associates are upholding the highest level of ethical conduct in their day-to-day business.

There is an ongoing commitment to engage only those suppliers that uphold the same principles as Abaco and where necessary ensure the implementation of corrective action measures. In the event that suppliers fail to take steps to cease or prevent adverse human rights impacts, Abaco will reconsider its business relationships with those suppliers. Abaco will never knowingly do business with suppliers who break the law. All Abaco suppliers are required to comply with Abaco's Integrity Guide for Suppliers and Contractors when doing business with or on behalf of Abaco.

Abaco's activities during Financial Year 1st January 2019 to 31st December 2020 relating to the prevention of slavery and human trafficking.

Supply Chain Management

Abaco source a wide range of goods and services from suppliers based in the United Kingdom and overseas. In all its dealings with those suppliers it strives to ensure that the highest ethical standards are reached at all times. As part of this ongoing requirement, there has been increased focus on ensuring commitments are made by those suppliers to ensure that slavery and human trafficking are not present in their own businesses and supply chains.

Amendment of internal policies

A review of Abaco's Code of Conduct and Business Ethics Policy and the Abaco Systems Integrity Guide for Suppliers and Contractors was conducted in 2020 to ensure its relevance and compliance with the Act. Abaco's continued commitment

Abaco recognises the importance of maintaining constant vigilance to identify and address any impacts associated with slavery and human trafficking throughout its supply chains. In recognition of the salience of these issues, Abaco is committed to continuing to enhance its capacity to identify, prevent and mitigate any actual or potential issues in this area.

Continued internal monitoring of its supply chains remains a priority for Abaco. Those suppliers which have been identified as high risk due to their territorial location and reach are more heavily monitored to ensure that their working practices (and those of their supply chain) are compliant.

Abaco employees who work in those areas of the business more exposed to supply chain risk are appropriately trained to ensure that such risks are contained. Regular training is also provided to all staff to help them understand and comply with Abaco's Code of Conduct and Business Ethics Policy. Abaco also has a confidential and anonymous employee concern reporting system in place that allows employees to report any concerns they have regarding conduct and legal compliance.
